Part C: Draft FOG 2018 AGM Minutes

Tuesday 20 March 2018 Lena Karmel Lodge, 26 Barry Drive, Acton ACT

Meeting opened 18:05. Geoff Robertson chaired the meeting.

Papers provided to the meeting were Agenda 2018, Draft Minutes 2017 AGM and SGM and a collation of Annual Reports 2017 (which had also been emailed to all members who received the March e-bulletin at the end of last week).

1. Attendance and apologies

Present: Alan Ford, Andrew Zelnik, Andy Russell, Ann Milligan, Geoff Robertson, Janet Russell, Jamie Pittock, John Fitz Gerald (minute taker), Judith Gamper, Juliet Beckman, Ken Hodgkinson, Kim Pullen, Margaret Ning, Michael Bedingfield, Paul Archer, Rainer Rehwinkel, Sarah Sharp, Shirley Daniels, Stephen Horn, Tony Lawson, Warwick Daniels.

Apologies: Barbara Payne, Cathy Robertson, Kat Ng, Linda Spinaze, Naarilla Hirsch.

2. Minutes of 2017 AGM

Minutes approved. Moved Jamie Pittock, seconded Kim Pullen

Minutes of 2017 SGM were then approved. Moved Sarah Sharp, seconded Rainer Rehwinkel.

3. Matters arising - nil

4. Reports. Geoff Robertson briefly summarised the material already circulated in his President's report. All contributors across a wide range of activities were sincerely thanked. His report compiled a table of the times put in by members and volunteers across all of FOG's endeavours and estimated total value of this contribution to community for the 2017 year to exceed \$300 thousand.

The Chair offered the opportunity to those who had written material for the package of reports to speak briefly:-

Membership by Sarah Sharp - encouraging that FOG membership remains as high as it has ever been, around 214.

Treasurer by Janet Russell - commended members to examine the full package of figures presented in the report collation and pointed to FOG's operating funds (ie excluding grants for on-ground projects) remaining positive with income more than expenditure. The role of book sales was acknowledged.

Acceptance of the Treasurer's Report and Audit Papers was moved by Andrew Zelnik and Tony Lawson. Carried.

Booksales by Sarah Sharp - major purchases are now from merchants (eg ANBG bookshop) and institutions (eg SELLS who issue the Floras to landholders needing information packages). Possibility of distributing some of the Flora information in electronic form still intended to be pursued.

FOG Supported Projects by Andrew Zelnik - the use of pubic fund donations via the initial set of 5 small grants has taken major time and effort by group members. However the processes are now set up, working well and new applications have been invited.

NCA projects by Jamie Pittock - a vote of appreciation was raised for Peter Beutel who has greatly supported FOG's objectives in several ways from within the NCA. Great contributions also from many volunteers.

Cooma Grasslands by Margaret Ning - the CILF spending and achievements are largely on track. Monitoring of numbers for the Monaro Golden Daisy hopefully will extend beyond Cooma grasslands out into the Monaro.

Advocacy by Sarah Sharp - initially pointed out that FOG's on-ground work is clearly positive for advocacy because submissions can reference not only theory and aspiration but also share direct experience from recent activity. Naarilla Hirsch was congratulated for being the best agent in the ACT keeping track of issues needing comment and feeding that on to inform Cons Council ACT and its other member groups (eg COG). FOG should be very pleased that its comments on the ACT Grassland Strategy were so widely appreciated and accepted. However, it is now becoming the norm for many other submissions to government that planning bodies largely ignore ecological issues raised, leading to an increasing level of frustration.

The meeting agreed to accept all reports - moved Jamie Pittock, seconded Andrew Zelnik

5. Annual Elections. President acknowledged those members who were standing down from committee.

John Fitz Gerald agreed to act as Returning Officer.

- a) President. Geoff Robertson was nominated by Naarilla Hirsch and John Fitz Gerald declared elected
- b) Vice Presidents. Kim Pullen was nominated by Geoff Robertson and Naarilla Hirsch. Declared elected, leaving the second VP position vacant.
- c) Secretary. Paul Archer was nominated by Geoff Robertson and Naarilla Hirsch. Declared elected.
- d) Treasurer. Janet Russell was nominated by Geoff Robertson and Naarilla Hirsch. Declared elected
- e) Committee. Andrew Zelnik, Kat Ng, Margaret Ning and Tony Lawson were nominated by Geoff Robertson and Naarilla Hirsch. Kat was not present but had written her agreement to be nominated. Juliey Beckman was nominated by Ann Milligan and Jamie Pittock. Ken Hodgkinson was nominated by Ann Milligan and John Fitz Gerald. Returning Officer pointed out that 5 more committee positions remained to be filled and Rainer Rehwinkel nominated himself, seconded by Michael Bedingfield. All 7 were declared elected.

Part D:

Draft FOG 2018 Special Meetings Minutes

Saturday 18 September 2018 Mugga Mugga Environmental Education Centre, Symonston.

A Special General Meeting (SGM) was held in conjunction with the annual mid-winter afternoon of talks and tea on 18 September 2018 at Mugga Mugga Environmental Education Centre, Symonston.

The FOG committee at its meeting on 24 July 2018 endorsed a proposal to recommend to the SGM that Sarah Sharp be awarded Honorary Life Membership. A notice of meeting was included in the FOG e-Bulletin 26 July 2018 as follows:

Members of FOG are invited to attend a Special Meeting on 18 August at Mugga Mugga Environmental Education Centre. It will take place during the mid-winter talks and tea afternoon (1.30–4.30 pm). The purpose of the meeting is to consider a proposal from the Committee to award Honorary Life Membership to Sarah Sharp in accordance with Rule 12 in the Friends of Grasslands' Rules.

Members at the meeting will be informed of the extraordinary contribution Sarah has made to Friends of Grasslands, to the support of grassy ecosystems, and to biodiversity and conservation more broadly. The citation for Sarah is separately attached to this e-mail as a pdf file. Sarah will be present at the meeting and we strongly encourage members who are able to attend to come and support Sarah by endorsing the Committee's proposal.

The SGM unanimously accepted the committee's recommendation to award Honorary Life Membership to Sarah. A report of the meeting was included in the FOG newsletter Sep – Oct 2018 as follows:

Sarah Sharp now an Honorary Life Member of FOG

At a Special General Meeting on Saturday 18 August, Sarah Sharp was awarded Honorary Life Membership of FOG, in accordance with Rule 12 in the Friends of Grasslands' Rules. More than 30 members were present to endorse the award; and those of us not present that day also say: "Congratulations Sarah! Very well-deserved!".

Sarah has made extraordinary contributions over the last 28 years – to FOG and to the rescue of grassy ecosystems and to biodiversity and conservation more broadly. In 1994, the year FOG was formed, Sarah was the Grassland Project Officer, ACT Parks and Conservation Service – Wildlife Research Unit. Thanks to Sarah and her colleagues, substantial initial recovery work had begun in 1992, the start of a four-year ACT Grassland Recovery Program. The resulting ACT Grassland Recovery Plan, later released as the Government's first Action Plan, included a recommendation to establish a Friends of Grasslands Group ... and here we still are! Sarah stepped off the FOG committee at the end of 2017, but she still contributes to FOG in many ways, including managing membership and sales.
